

## Release and Waiver of Liabilities and Grant of Publicity Right

I understand that while traveling to and attending events at the Boone and Crockett Club's Theodore Roosevelt Memorial Ranch (the "Ranch") and participating in Ranch staff-led programs, if any, I may be exposed to a variety of risks and hazards, foreseen or unforeseen, that cannot be eliminated without fundamentally altering the unique character of the Ranch and its programs. These inherent risks include, but are not limited to, the following: risks and hazards associated with the rustic, historic nature of the Ranch and its structures, environmental risks and hazards associated with outdoor recreation in a remote, backcountry setting, including weather and unpredictable forces of nature. I understand that this description of risks is not complete and that other unknown and unanticipated risks may result in property loss, injury, or death. As a condition of my attendance at the Ranch and participation in any Ranch staff-led programs, I agree to assume full responsibility for all the risks that such activities may entail. My visit to the Ranch and my participation in its programs are entirely voluntary, and I elect to participate with full knowledge of the inherent risks.

### Release and Indemnification

In consideration of my attendance at the Ranch and participation in any Ranch staff-led programs and for other good and valuable consideration, receipt of which is hereby acknowledged, I voluntarily elect to assume all risks of loss or damage to any property or any injury or illness, including death and disability, and hereby knowingly, freely, and voluntarily release and agree to indemnify and hold harmless the Boone and Crockett Club (the "Club"), its members, directors, officers, staff, employees, volunteers, and agents from any and all liability, claims, demands, or causes of action whatsoever by reason of any damage, loss, expenses, injury, illness or death arising from or relating to: (1) my visit to the Ranch; (2) my participation in the Ranch staff-led programs; and (3) any act, omission, or negligence of the Ranch staff, employees, and volunteers related to the provision of, or failure to provide, first aid or any kind of emergency medical care. If any term or provision of this Release and Waiver is determined to be invalid, illegal, or unenforceable by any court of competent jurisdiction, such term or provision shall be modified to the extent necessary to allow enforcement and to give effect to the intent of the parties. I authorize the Club and its staff, employees, and volunteers to administer first aid or emergency medical treatment or to secure such medical services, as they may consider necessary or appropriate.

One of the best ways to explain our mission is through photographs and testimonials of visitors and program participants. The Club and the Ranch occasionally use these items in promotional materials (e.g. brochures, newsletters, annual report, website, social media, etc.).

I hereby grant to the Club and anyone authorized by the Club, permission to (a) photograph, film and record me (on film, videotape, audiotape, illustration, digital media or otherwise) at any time while I'm present on the Ranch (the "Photo Shoot"); (b) edit and modify any resulting video, photographs, recordings, media, illustrations or other materials (collectively the "Materials"); and (c) use, duplicate, publicly display, distribute and make derivative works from such Materials, in whole or in part, along with my name, likeness, image, voice, and comments, in any manner or media now known or unknown and for any purpose in connection with the Club and its business, including in commercials, on the Club website, and for publicity, promotional, advertising, business, informational, educational or other purposes of any kind. I hereby release the Club, and its respective agents, representatives, contractors, officers, directors, employees, heirs and assigns, and anyone acting under its authorization (the "Authorized Parties"), from any claims relating to the Photo Shoot or the Materials, including that the use of the Materials as authorized herein violates any of my rights, including without limitation any rights of publicity or privacy. I acknowledge that there is no obligation to make any use of the Materials and that all rights granted herein are fully sublicensable and assignable. I further acknowledge that (a) this grant is required for my presence at or participation at the Ranch, (b) I will not be permitted to participate in the activities at the Ranch without this grant, (c) I will not receive any monetary compensation in exchange for this grant, and (d) I do not have any claim to any rights or interest in or to the Materials.

This grant and release is perpetual and irrevocable, so that Company may proceed in reliance thereon. I have read, and agree, to the above.

This Release and Waiver of Liabilities shall be binding on my spouse, family, heirs, executors, administrators, successors, and assigns.
